

## Celina Insurance Group And Employees Scholarship

### 2021 Scholarship

Application must be submitted by 4:00 p.m. EST on March 1, 2021.

Celina Insurance Group and its employees have established a scholarship fund with the Mercer County Civic Foundation. The fund awards three \$1,000 scholarships to three 2021 high school graduates. The graduate must be pursuing a degree in an insurance industry-related major, such as Accounting, Actuarial Science, Business, Communications, Computer Science, Finance, Pre-Law, Risk Management & Insurance, etc.

Eligible students must either reside or graduate from a high school in Mercer or Auglaize County or be a child/grandchild of a current Celina Insurance Group employee (no county constraint). In the spring of 2022, each scholarship recipient will be eligible for the Don Montgomery Memorial Renewal Scholarship for \$500 if the recipient meets the qualifying guidelines.

Top applicants will be considered based on an essay topic noted below. We will notify the selected winners in late spring 2021.

#### **ESSAY TOPIC:**

*Most insurance companies factor in a credit-based insurance score to determine premiums. Credit-based insurance scores use the risk of loss to help determine potential insurance premiums. Indicate and describe actions that you as a potential insurance policyholder can take to help build your credit score and lessen your insurance premium.*

If a scholarship winner enrolls in at least six or more credit hours during each semester at Wright State University – Lake Campus, the Western Ohio Educational Foundation (WEOF) will award the recipient a matching scholarship for an additional \$1,000. WEOF will also match the Don Montgomery Memorial Renewal Scholarship in the amount of \$500 in 2022 if the recipient qualifies.

Students who plan to attend WSU Lake Campus are encouraged to submit the WEOF scholarship application by February 1, 2021. By meeting this deadline, eligible applicants will be considered for any of the 500 WEOF scholarships totaling over \$200,000. These scholarships are exclusively for WSU Lake Campus students.
